**Deposits** *Residential*

Deposits are based on credit inquiry through On-Line Utility Services. Customers with green rating have no deposit. A yellow rating: Elect-\$100, Gas-\$100, Water-\$50. A red rating: Elect-\$150, Gas-\$150, Water-\$75. All customers must pay a \$25 service fee at the time of application. Deposits refunded after 2 years if customer has a green credit rating with On-Line Utility Services. Note: Renters applying for service must have rent receipt in same name as for the utility service.

***High Risk***

First time disconnection for non-payment, \$25 reconnection fee. Second time disconnection in 12-month period, a high risk deposit must be paid, doubling the maximum deposits on the account plus a \$25 reconnection fee. Each time after the second time a \$50 non-refundable high risk fee is required plus a \$25 reconnection fee.
