

Harriman Utility Board Broadband Fiber Project

Intent to Bid - Telcom Hut RFP

Project Summary

The Harriman Utility Board (HUB) in Roane County, TN, is initiating a fiber construction project to offer high-speed broadband internet access within its service territory. As part of this initiative, HUB requires the installation of two telecom huts to support the new fiber network infrastructure. Fiber construction is set to begin in May 2025, with the first telecom hut scheduled for delivery in June and the second in July. The project involves the construction of 395 miles of mainline fiber, initially serving 2,920 homes and businesses. The network is designed to be capable of serving the entire HUB service area, which includes 7,300 homes and businesses with room for expansion. These telecom huts are essential for housing the equipment necessary to manage and distribute the fiber network, ensuring reliable and high-speed internet service to the community. HUB is seeking bidders that can provide the telecom huts (new or quality refurbished) and assist with transport and onsite installation logistics.

Intent to Bid

The undersigned certifies an understanding of the nature and character of the work to bid and is sufficiently skilled and equipped to provide the requested services. HUB will use both subjective and objective criteria to evaluate each applicant's qualifications. Submitting this Intent to Bid does not guarantee any award or invitation to future project bids.
